The meeting was called to order by Council Vice President Robin Kessler at 11:43 am with a reading from Ephesians 4:1-7.

**Members present:** Robin Kessler, Sharon Lightner, Diane Schultz, Betty Boslet, Evelyn Holsinger, Lori and Mike Savino, Bob Hench and Donna and Bill Wilt.

**Members absent:** Mark Hoover and Shirley Manbeck. Robin Kessler went over last year's Congregational Report. Diane Schultz made a motion to accept the report and Betty Boslet seconded.

New Business: All Committee reports were reviewed by the Congregation with Robin Kessler emphasizing certain items in the report. Evelyn Holsinger made a motion to accept the Committee reports and Betty Boslet seconded. Betty Boslet, Robin Kessler, Sharon Lightner, Shirley Manbeck and Mike Savino accepted another 3-year term on Council. Donna Wilt made a motion to accept the individuals to Council for a 3-year term and Diane Schultz seconded. The White Gift Fund balance was \$634.95. Council decided to no longer have a White Gift Fund so the money was moved to the General Fund. Council went over the proposed spending plan with no objections. #### Saint James Evangelical Lutheran Church Ministry's Annual Report 2024

That this time, Saint James has not Pastor, but the Congregation continues to be involved in Ministry. During the last year, the Congregation has continued to have Weekly Worship Services lead by Lay Worship Leaders and Ordained Pastors.

Saint James during this past year has been rather stable. Our average worship attendance for this year was 9 which is slightly down by 1 weekly worshiping member from last year, when it was 10. This decline is due to deaths and illness. Our finances are pretty much a repeat of last year with a slight decrease in giving. We continue to draw upon our accumulated resources, but we are still not in any danger of depleting these investment funds in the near future.

The number of homebound members to whom home communion was taken to has remained the same with about 2 compared to 4 from last year. Of course, this list can grow if currently active members become homebound. As always, the question before us is what would the Lord ask of us now that Saint James has no permanent pastor? What are the possibilities of calling another Transitional Interim Pastor at Saint James? What is our future? We do not need to be afraid of those questions, because the Lord will be with us whatever the future brings. The possibilities that we could call a Transitional Interim Pastor are slim and we will have to continue to have Pulpit Supply for the foreseeable future. The Lord is with us now. Saint James has seen bigger and flashier days, but the Lord is still in our midst. We know that Jesus is present whenever two or three gather in His name. Well, we are nine souls, and the Lord is with us moving us toward God's good conclusion for us and all of God's creation.

The Finance Committee met yearly to discuss the financial issues of the church; including review of the investment portfolio with Raymond James and GBU as follows:

The 10/1/23 - 9/30/24 audit was done by Church Council. The Church Council has been reviewing all church transactions and no irregularities were found.

Attendance continues to decline, and contributions have slightly decreased. The total transfers from the Raymond James account were \$57,500.00 to cover expenses.




